

Referral Agreement



October 19, 2009

This agreement is between REBUL PACKAGING PTY LTD ABN 62102702714 (Rebul) and Pack & Send _____ (The Referrer) regarding the referral of Rebul products to 'The Purchaser' (the individual or company making the purchase of Rebul products).

Referral commission for an initial order

- This is where a new order is received from a new client to Rebul, where Rebul has never made crates for this company or person historically.
- To be eligible for referral commission, prior to the initial order being received from 'The Purchaser' to Rebul, 'The Referrer' must have previously communicated in writing (email or fax) to Rebul the details of 'The Purchaser':
 - o Company name (where applicable)
 - o Individual contact name
 - o Contact details of the individual
 - o Background information on which the referral was provided (e.g. what is the client's crating need?).
- The purchasing client must also recognize 'The Referrer' for the referral
- The initial order will attract an 8% commission on the total of the initial invoice (excluding GST and delivery).

Referral commission for recurring orders

- All subsequent orders from 'The Purchaser' referred to Rebul by 'The Referrer' will attract a 4% commission payable to 'The Referrer' on the total of each invoice (excluding GST and delivery).

Payment of referral commission

- Invoices will be sent directly to 'The Purchaser' immediately following dispatch of 'The Purchaser's' order.
- It is agreed that commission will only be paid to 'The Referrer' in the first week of the month following the month when full and final settlement of invoices by 'The Purchaser', to whom 'The Referrer' has referred Rebul products.
- Commission is based only on payments received from orders placed by referrals of 'The Referrer'. No commission will be paid on crates ordered by 'The Referrer'.

Referral Agreement



Conditions

- Reports on 'The Referrer's' referral client's revenue activity will be emailed from Rebul to 'The Referrer' in the first week of the month following the previous month where sales activity has occurred.
- Acceptance of orders placed by 'The Purchaser' to Rebul is at the sole discretion of Rebul. Rebul is under no obligation to accept any order.
- If no initial order is received from 'The Purchaser' within 3 months from the date of the initial referral by 'The Referrer', the exclusivity of that customer to 'The Referrer' will lapse.
- 'The Referrer', its employees and associates, are required to present Rebul products willingly and honorably with strict levels of professionalism and integrity at all times.
- This contract is valid for 2 years, from the date of signing by the last of the parties to the agreement.
- Rebul reserves the right to terminate this agreement should Rebul believe that any of the above conditions to have been breached. If terminated, notice will be given in writing and will be effective immediately.
